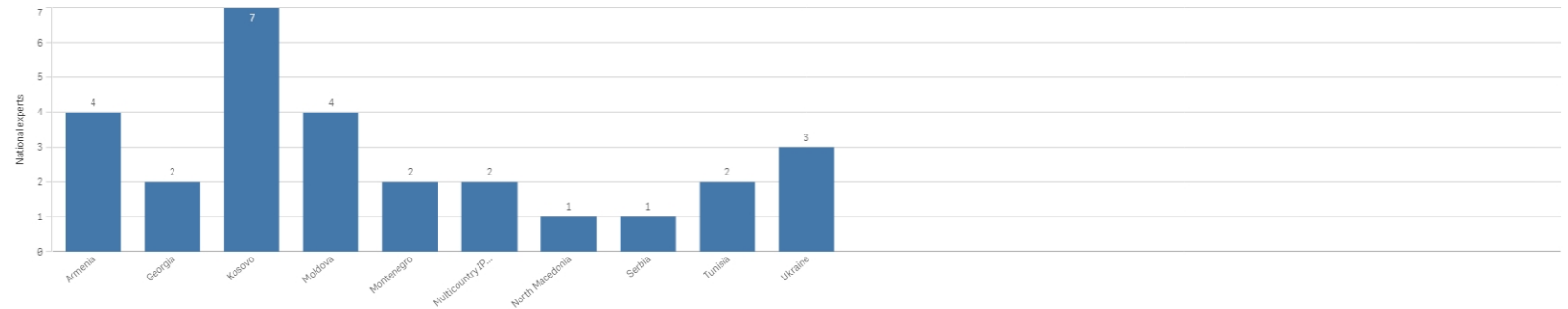

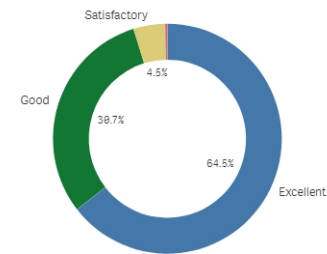

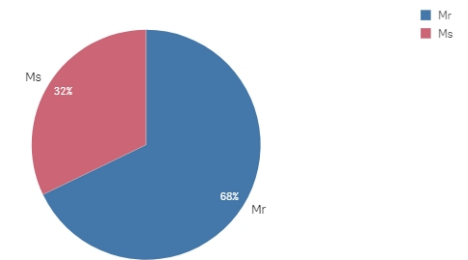

Gender data for Lithuania experts

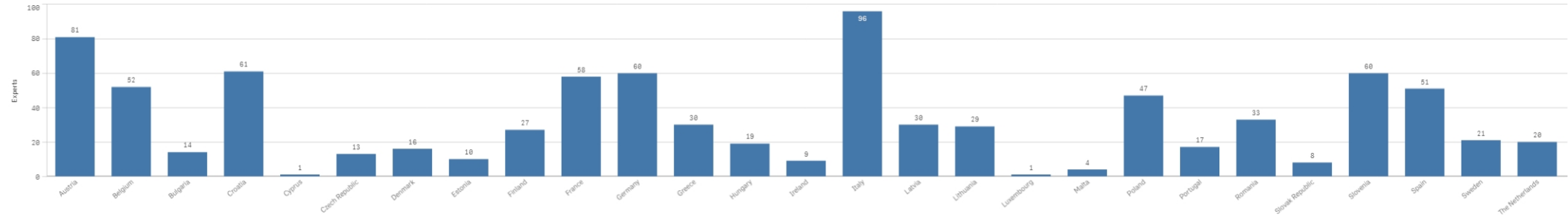
